## **IRIS School Accessibility Plan Policy**

- Provide training for staff on how to implement IEPs and support diverse learning needs.

## • Emergency Preparedness:

 Develop and communicate emergency procedures that ensure the safety of all students, including those with disabilities.

## 7. Training and Awareness
